File Creation and Submission Guide (CSV or TXT)

Facilities must submit flat, delimited text files for validation (CSV or TXT). Header rows are required for submission.

Please note:

- Data elements are to be delimited with semi-colon;
- All elements are to be enclosed with double quotes " " including numeric fields and blanks
- Composite data elements are delimited with a colon:
- One case per line
- One file submission may contain data on patients across multiple facilities, so long as the
 correct PFI is reported for each case. In addition, attempts to upload data containing PFIs
 that are not associated with your user account will result in an automatic rejection of your
 upload by the Portal.

File Templates

File templates are updated with each iteration of the data dictionary, and can be accessed on the <u>Data Dictionary</u> page of the sepsis portal.

File Naming

Although there is no required file naming convention for files submitted to the Sepsis Data Collection Portal, we recommend developing a naming convention to be used for all files your facility submits to the Portal. Developing a consistent naming convention will facilitate the process of file correction should discrepancies in data arise. Some elements that could be used in your naming convention include:


- Sepsis data collection identifier (e.g., "sdc")
- · Date of file upload
- Submission period
- Adult or Pediatric designation
- Initials of user responsible for upload

File Submission

Once logged in to the Sepsis Data Collection Portal, click on either 'Adult', 'Pediatric', or 'Partial' (depending on which type of cases you will be submitting) followed by 'Submit File' found on the top navigation bar.
